- Project Outcomes



- Agreement on the project 15/NMF PL 15/14 Secure Europe without borders was signed between the Ministry of Internal Affairs and the Regional Police Headquarters in Łódź on the 30th of December 2014
- The project provided **11** specialistic trainings on computer forensics, dedicated to **90** police officers and employees from forensic laboratories and intelligence divisions as well as divisions for the fight against cybercrime from 6 police units
- Total project value 1 288 930,00 PLN

- Evolving common models of combating cross-border crimes














Satisfaction Rate – Evaluation Outcomes


